

For the rest of the year the indicators are positive and optimistic for Ireland's economic outlook in 2025 with several key indicators suggesting robust growth. The European Commission projects a GDP growth of 4.0% in 2025, following a slight contraction in 2024. This rebound is anticipated to be driven by a strong labour market, low headline inflation, and a favourable external environment. The commitment by the EU to greatly reduce the bureaucracy imposed on business through a review of newly proposed legislation and its impact on business with a review of existing legislation is welcome. The launch this month of the EU Compass offers a positive contribution from the EU to help sustain growth. This is one of many initiatives that need to be brought forward as outlined in the Draghi Report published last October 2024.

Our multinationals are a key part of our economy and in South Dublin we welcome their major contribution to both our county and our country. If we look at Modified Domestic Demand (MDD), which offers a picture of domestic economic activity not including the multinational sector, it is expected to grow between 3% and 3.5% in 2025. This growth is underpinned by steady employment rates and real wage increases, bolstering household incomes and consumer spending.

Inflation rates have been on a downward trend, with headline inflation projected at 1.9% for 2025. The labour market remains robust, with the unemployment rate stable at approximately 4.4%. Employment growth is expected to continue, supported by high net inward migration and increased labour force participation.

The key challenges that are under our own control are infrastructure, housing, energy production and supply, water supply and distribution and climate abating measures. For too long our focus has been short term without the investment and planning for the longer term; this has caught up with us and needs to be addressed as a matter of urgency, starting with the endless problems with our national planning system.

Global geopolitical tensions and the possibility of increased protectionist measures, particularly from the U.S., could impact Ireland's trade dynamics. Given Ireland's significant economic ties with U.S. multinational corporations, any shifts in U.S.

trade policy may influence corporate decisions and, by extension, the Irish economy. Our multinationals have strong roots here and a committed and talented workforce; these are key factors when considering any future changes.

In summary, while Ireland's economic prospects for 2025 are positive, with expectations of strong growth, low inflation, and a resilient labour market, it remains essential to monitor external factors that could pose risks to this outlook and for all our members to remain adaptable and resilient.

A little bit of home is always a good experience. I was attending a seminar on Demystifying Data Centres and their role in the EUs Twin Transition. Very good speakers including MEP Barry Cowan and Niamh Gallagher, Director, Infrastructure Public Policy (EMEA) AWS.

EU Bureaucracy



EU regulation is a powerful tool that enables trade between countries that is beneficial and essential to our economies both within the EU.

This same bureaucracy protects consumers and safeguards our interests in many fields from shopping online to medicine control. It is needed and valued, however sometimes you can have too much regulation. With 98% of EU firms defined as SMEs we need a more user friendly responsive regulatory system. Currently 61% of businesses see EU regulation as an obstacle to investment.

I along with other EU employers' representatives from across the EU were able to raise these issues with Antonio Costa, President of the European Council when he addressed our meeting last week. We made clear the EUs competitiveness is at risk, and we can see first the struggles of our members to deal with these challenges including too many rules and procedures for businesses. It was made clear there have been too many declarations with too little action, too many promises with little results. We specifically asked that to enable us to get back our competitive edge that the many adopted plans of the EU like the SME test are implemented.

A clear example of the multitude of over regulation can be seen in one simple example in the Draghi Report. In the last 5 years the US published 3,000 new pieces of legislation relating to business the EU published 13,000 that's 10,000 more pieces of legalisation we need to deal with than those firms based in the US.

Eurochambres News - Competitiveness
Compass: It's time to move on from

The long-awaited "Competitiveness Compass for the EU" was presented by the European Commission on 29th January, jointly with the Annual Single Market and Competitiveness Report. While the latter points to a worrying increase in EU's market fragmentation, the former should represent the economic doctrine for the years to come.

While fully supporting all efforts to revive Europe's competitiveness, Eurochambres questioned in its initial reaction whether the Compass will significantly shift the needle for our struggling business community.

Eurochambres President Vladimír Dlouhý, commented: "It is time to move on from window dressing to substantive initiatives and far-reaching reforms that will stimulate innovation, investment and employment, starting I hope with next month's simplification omnibus package."

Major Movie Studio coming to South Dublin County

South Dublin Chamber welcomes the good news that planners have given the go-ahead for proposed "Dublin Fields" movie studios for a site in South Dublin that may create as many as 2,800 jobs on and off site when operational.



South Dublin County Council awarded a 10-year planning permission to Lens Media Ltd for the 56-acre site which includes 20 individual structures amounting to over 74,000sq m of gross floor space. The development includes six buildings that comprise 11 internal sound stages along with ancillary offices at Grange Castle Business Park, Co Dublin.

A planning report by consultants Tom Phillips+ Associates lodged with the application stated that Dublin Fields "will have all the elements that will lure top productions from around the world"

The planning report stated that the project "will be a world class studio" and occupy the top tier of movie studios globally alongside Pinewood in London and Trilith in the US.

A spokeswoman for Lens Media said the studios "will more than double the current soundstage offering in Ireland, acting as a catalyst for the indigenous screen industry and catering for growing, unmet production needs. Once fully operational it will directly support in the region of 2,800 jobs and over 2,100 indirectly.

In their report, Tom Phillips+ Associates stated: "We believe this will be the largest stage in the European Union, and a unifying step in making Ireland a new hub for the movie and TV industry."

Tesco Ireland Expands Stronger Starts Food Programme to 80 More Schools



Tesco Ireland is adding 80 new DEIS schools to its Stronger Starts Food Programme, which provides free fresh fruit and vegetables to primary school children. New research from IPSOS B&A highlights the programme's significant health, educational, and financial benefits for families:

Tesco Stronger Starts Food Impact Report findings - additional detail.

1. Nutritional Support and Healthy Eating

- 4 out of 5 parents/guardians agree that Tesco Stronger Starts Food is positively impacting children's diet/physical health. This sentiment is also reflected by two-thirds of educators.
- 82% have noticed a greater interest in eating healthier food and snacks.

2. Educational Outcomes

- 76% observed increased motivation for going to school / learning.
- 69% of educators report fewer complaints of hunger at school.

3. Family Engagement

- 83% of parents/guardians report a positive impact on the family sitting down and having meals together.
- 77% of parents/guardians see greater child involvement in cooking and food preparation.
- 84% of parents/guardians note that it encourages stable routines for cooking and meal preparation.

4. Financial Relief and Food Insecurity Reduction

- 84% state that the programme has improved their ability to always have food at home.
- Over half of respondents report the provision of 2-4 extra meals each week.

Tesco CEO. Natasha Adams commented: "This research conducted by IPSOS B&A highlights the significant positive impact that the Tesco Stronger Starts Food programme is having on children and families across Ireland. Our commitment to championing children's health is at the core of this initiative, and based on the report findings, we are announcing the expansion of the programme to reach an additional 80 DEIS schools along with the pilot of a schoolsbased cookery programme to bring essential life skills to children, based around food."

Minister for Social Protection, Dara Calleary, who spoke at the report launch event in Dublin commented: "Ensuring children are eating healthy nutritious food is something which is close to my heart and the wellbeing of our children is paramount to this government. My department does important work on this through the School Meals Programme. However, Government can't do it alone. We need to work together across all sectors if we are to make the change we want to see. For that reason, I am delighted to see the great work being done through the Tesco Strong Starts Programme."

South Dublin Chamber welcomes An Bord Pleanála decision approving a Railway Order for the Dart+ South West scheme between Heuston and Hazelhatch Stations.




